The portfolio adheres to the guidelines set by Regulation 28.

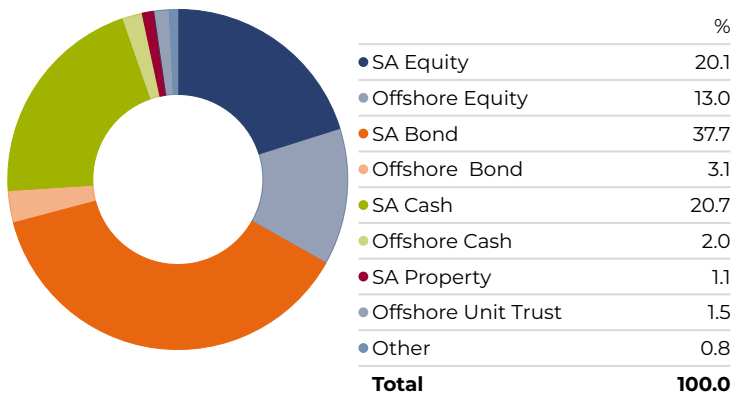

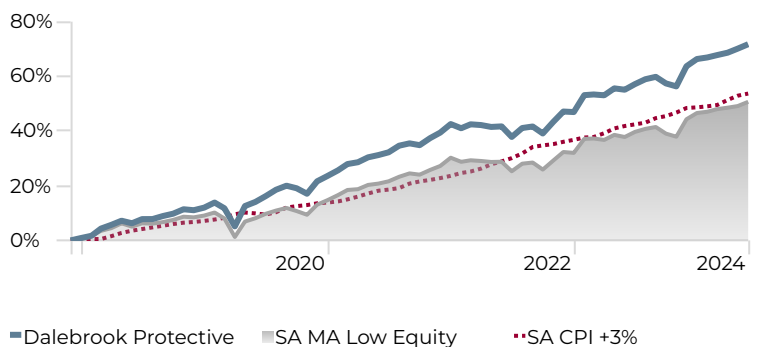
